

ZET10 - Bonus Terms & Conditions

1. For each type of bonus, there is only one bonus offered per extended household. Customers who are related to other customers by one or more of the following: name, phone number, postal address, email address, IP address, name on credit/debit card, credit/debit card number, device ID and any other form of identification information may result in the bonus being withheld.
2. If you do not wish to receive the bonus, do not enter the relevant bonus code when requested or you can let us know by contacting us.
3. Open trades of Clients who have not logged in for more than one week and/or never deposited any own funds can be closed and the funds will be debited from their account. The Company accepts no liability or responsibility for the financial outcome resulting from the automatic closing of such open positions.
4. Residents of certain countries may not be eligible to participate in one or all Bonuses. The Company reserves the right to restrict Clients from participating in a bonus at any time without notice.
5. This offer is subject to the User Agreement and abuse of this offer may result in the bonus being withheld.
6. ZET10 reserves the right to amend, withdraw or restrict this bonus promotion at any time.

1. Phone Verify Bonus

- 1.1. Clients are eligible to participate in the Phone Verify Bonus by registering and verifying their telephone number by receiving an SMS or phone call before their initial deposit.
- 1.2. Participating Clients will receive a Phone Verify Bonus of 50 EUR which will be credited to the trading account for immediate use.
- 1.3. After receiving the Phone Verify Bonus the Client has a period of 7 days in which to make a deposit and open at least one position.
 - a) If the Client fails to deposit and has open position based on the bonus funds, then on the 8th day all open positions will be closed and the account balance (including bonus and profits) will be reset to zero.
 - b) If the Client has deposited but not traded, then on the 8th day, the bonus funds will be debited from his trading account.

- 1.4. Bonus expires after 90 days, if the required minimum trading volumes are not satisfied.
- 1.5. Client may withdraw the Bonus or profits gained in his trading account, subject to the fulfilment of the trading points in the required timeframe to make the entire Bonus amount available for withdrawal. (The "Required Trading Points") Each withdrawal shall be first considered on the account of profits and then after from the bonus.

2. First deposit bonus

- 2.1. Clients are eligible to participate in the First Deposit Bonus on their initial deposit.
- 2.2. The First Deposit Bonus is a "**Balance bonus**" is subject to all terms of "Balance bonus" (Section 3).

3. Balance bonus

The Balance bonus can be offered in different bonus levels or amounts.

Subject to receiving the redeposit bonus promotion, the following terms will apply:

- 3.1. Participating Clients will receive a Balance Bonus which will be credited to the trading account for immediate use.
- 3.2. The "Required Trading Points" are based on the bonus level and amounts and can be updated by the company without prior notice.
- 3.3. Client may withdraw the Bonus or profits gained in his trading account, subject to the fulfilment of the trading points in the required timeframe to make the entire Bonus amount available for withdrawal. (The "Required Trading Points") Each withdrawal shall be first considered on the account of profits and then after from the bonus.
- 3.4. If the Client wishes to withdraw the deposit funds from the Trading Account before achieving the Required Trading Points, the withdrawal would be made available, however the Bonus and the profits in the Trading Account will be cancelled and/or forfeited by the Company.
- 3.5. The Company's normal terms and conditions apply and we reserve our right to amend and/or cancel the conditions of any bonus promotions at any time. By continuing to participate in the bonus promotions you agree to their terms and conditions.

3.6. Any transaction during and after the Bonus period that breached the terms of this Agreement, will result in the cancellation of the entire bonus according to the sole discretion of the company.
